Preliminary Design

Your licensed design professional is required to submit a written test hole report with a stamped preliminary site plan.

Parcel Identification

This is the tax parcel number for your property. If you don't have a copy from your tax records, the building department, or your real estate agent, you may obtain a parcel number from the property control section of the Spokane County Assessor's Office. This information is used to determine the current legal owner of the property.

Site Information

- Identify with some type of signage
- Vehicle access to the property
- · Testholes must be recently excavated and marked clearly

\$560.00- Application Fee

This is used to cover the cost of a site inspection, to verify testhole findings, and basic design plan review. This fee must be submitted at the time of application. There may be a charge for additional testhole inspections.

\$820.00 - Permit Fee

This covers the cost of processing your system approval and inspection of the system. The fee must be paid prior to permit issuance.

\$100.00 - Private Water Supply Review Fee (for private wells only)

Growth Management Legislation requires that if a private well serves a residence, evidence must be submitted to us to ensure that an adequate potable water source is available prior to building permit approval. This fee covers the cost of processing this information.

These are the most commonly incurred fees. Depending on your project, additional fees and documents may be required. If so, you will be informed after your application has been initiated. We accept MasterCard, Visa, Discover, checks, or cash. Please make checks payable to: SRHD - EH.

Check with the Building and Planning Department for possible Critical Areas Ordinance, Flood Zones, Wetlands, etc. for impacts to property development, including the on-site sewage system.
