The thousands of flight attendants based in SFO were not represented by their own elected President at this important meeting. Instead, the vote of our base was cast via proxy.

As we all know, the combined contract will ultimately shape our pay, benefits, and work rules over the next decade. Our financial and professional futures demand the full, undivided attention of our elected officers. Yet our current LECP finds it perfectly acceptable to run a political campaign rather than attend MEC meetings which have a direct effect on our careers.

This is exactly why SFO needs change.

Because the incumbent candidates cannot run on their record, they would have you believe they should be reelected solely because they have the most "experience." What has their experience brought you?

- Are you experiencing a better reserve system?
- Are you still on A/B Rotation?
- Do you have a better quality of work life?
- Were you given the opportunity to learn about the JNC candidates and provide your vote as to who would represent you for a joint contract?
- How far are we into being a combined work force?
- Are you happy with the Expedited Tentative Agreement?
- Was the sCO pay rate the floor as they claimed? You still make significantly less than your sCO counterparts.


