Violation Declaration: In the Ninth Race on July 15, 2014, Trainer Alex Clarkson, acting as an Authorized Agent on behalf of Owner Larry A. Carter, filed a claim for the 8YO gelding "It Happened Again". Pursuant to IHRC Rule #71 IAC 5.5-6-1 (a), for a person to act as an Authorized Agent the person shall obtain a license from the Commission. While Mr. Carter had provided the required appointment of Mr. Clarkson as his Authorized Agent, Mr. Clarkson did not complete and pay for his Authorized Agent license. In addition Mr. Clarkson filed another claim on behalf of Owner Susan J. Hebenton, which is not permitted under IHRC Rule #6.5-1-4 (f) which states: "Owners utilizing the same trainer may claim different horses from the same race."

Based on the information before them, the Stewards have ruled the claim of "It Happened Again" is hereby voided, Mr. Carter is ordered to return the horse to the previous owner, Maggi Moss and the Horsemen's Bookkeeper is directed to refund the amount of the claim along with applicable taxes to Mr. Carter.

Appeal Process: Pursuant to 71 IAC 10-2-9, anyone who is aggrieved or adversely affected by this ruling may appeal to the Commission. Such appeal must be filed with the Commission within fifteen (15) days of this ruling.

Fine Statement: Any Person failing to pay a fine within seven (7) days may be summarily suspended pending the payment of the fine, however when a fine and suspension is imposed, the fine shall be due and payable at the time the suspension expires, unless otherwise ordered. All fines shall be paid to the Commission.

Suspended Persons: Unless the ruling specifically states otherwise, any person suspended or determined to be ineligible for licensing shall be excluded and denied access to all facilities under the jurisdiction of the Commission, including satellite facilities, during the period of suspension or ineligibility.
