Terms & Conditions - Please read carefully:

- The 2015CCC sets off from Calais on Saturday 13th June 2015 and finishes at an end-of-event gathering/dinner in Alençon on Saturday 20th June 2015. Precise details of where and when will be provided well in advance.*
- The recommended route will be provided in advance and each team will receive a pack, containing information pertinent to the Event.
- The cost is £85 per vehicle (see payments below) and payment in the form of cheque or bank transfer needs to have been received by **November 1st 2014.** In the event of withdrawal a full refund will be given until the February 1st 2015 cut-off date, after which no refund can be given. The fee covers administration, information pack, one t-shirt and sticker pack.
- VEHICLE ELIGIBILITY: Any Citroën car produced during or prior to 1995 is preferred, although any Citroën will of course be welcome. Cars entered must have current MOT (or CT) as appropriate and valid tax (UK). It is necessary that the vehicles be in a road-worthy condition. The mandatory safety and emergency kit must be carried as required by law. In addition, each member expecting to drive must hold a valid driving license and be appropriately insured for driving in France.
- Each team recognises that participation in the Event is **entirely self-funded:** It is the team's responsibility to meet the costs of crossing(s), accommodation, fuel, food etc. as well as covering any extraordinary costs such as vehicle repairs, medical treatment or fines.
- The Event is a **non-commercial road trip holiday** for like-minded Citroën enthusiasts who share a passion for the marque and as such the Organiser does not accept liability for any damages or losses that may be incurred by, for or to the participants in undertaking the Event. In particular, medical/legal travel insurance for the participants and provision for roadside assistance/recovery and repatriation of vehicles is the team's responsibility.
