Introducing ourselves

NGO ALLIANCE is a membersonly organization of experienced
international representatives from a wide
range of non-governmental organisations
(NGOs), accredited with the United
Nations (UN) or related agencies, who
have come together to provide
information that will enable newly
accredited NGOs and their
Representatives to be more efficiently
engaged with the UN of Geneva
(UNOG).

We created NGO ALLIANCE because we recognized a very real need for more information. Like you, we, too, were once newly accredited, and we were unsure about where or how to start working with the United Nations and all its affiliated agencies.

It took many of us years to find our way around, frequently feeling frustrated and anxious with a wish for friendly, uncritical guidance that would enable us to immediately put our passion and expertise to good use.

Eventually, we recognized that the various UN offices in New York, Geneva and Vienna operate in different ways, have different institutional cultures and offer diverse opportunities for NGO participation. Not only that, their objectives, giving the illusion of overlap, are actually often diverse and changing.

Because of past frustrations and countless meetings listening to NGOs expressing similar encounters with the complex architecture of the UN system, we became convinced of the need for targeted assistance to new NGOs to help them integrate quickly and effectively into the UN of Geneva. The work of civil society in Geneva is inherently expensive but it should and can be cost effective.

We have created NGO

ALLIANCE to help overcome the inevitable teething problems associated with penetrating the arcane world of UNOG. Our executive board volunteers their time to make your time more productive. We provide step-by-step guidance to the UN world that awaits your NGO, offering assistance on how to operate more efficiently during your visits to Geneva.

One of the most useful tools to begin with is our monthly digital newsletter which provides information and insider tips throughout the year on UNOG and related agencies and how they work with NGOs. There will also be a website, accessible to members only, with continuously updated information that you will need while at UNOG.

Why Geneva?

This is a great place for NGOs to begin their UN adventure. While internationally well-known, Geneva is also very manageable in size. It boasts a clean, efficient and affordable public transportation system, facilitating regular access to and from Geneva, as well as the downtown area. In addition, Geneva offers a range of comfortable accommodation options.

Coming to Geneva allows for crucial networking, including participation in the often collective work of un statement preparation and/or cosponsorship, and attendance at various parallel events that take place during the human rights council.

The Human Rights Council

WG Discrimination Against Women was established by the HRC in 2010 as there has been insufficient progress related to he Convention on the Elimination of ALL Forms of Discrimination against Women (**CEDAW**) which is often described as an international bill of rights for women.

Consisting of a preamble and 30 articles, it defines what constitutes discrimination against women and sets up an agenda for national action to end such discrimination.

Universal Periodic Review - UPR The Universal Periodic Review (UPR) is a unique process which involves a review of the human rights records of all UN Member States. The UPR is a HRC driven process, which assessesthe actions States have taken to improve the human rights situations in their countries and to fulfill their human rights obligations. The UPR is designed to ensure equal treatment for every country when their human rights situations are assessed. The ultimate aim of this mechanism is to improve the human rights situation in all countries and address human rights violations wherever they occur.

The **Human Rights Advisory Committee**, composed of 18 experts, has been established to function as a think-tank for the Council and work at its direction. The Advisory Committee replaces the former Sub-Commission on the Promotion and Protection of Human Rights.

The **Human Rights Council** is responsible for strengthening the promotion and protection of human rights around the globe and for addressing situations of human rights violations and make recommendations on them.

The Human Rights Council


The Human Rights Council (HRC) is an inter-governmental body within the United Nations system made up of 47 States. It is responsible for strengthening the promotion and protection of human rights around the globe and for addressing situations of human rights violations and make recommendations on them. It has the ability to discuss all thematic human rights issues and situations that require its attention throughout the year. It meets at the UN Office at Geneva.

Special Procedures

is the mechanisms established by the Human Rights Council to address specific issues in all parts of the world.

It calls on mandate holders, e.g. Special Rapporteurs or Independent Experts to examine, monitor, advise and publicly report on human rights situations.

Thematic Mandates there are 36 thematic issues that are addressed by the HRC



Country Mandates address human rights situations in specific countries or territories.

Introducing....Ms. Virginia Dandan UN Independent Expert on human rights & international Solidarity

The independent expert on human rights and international solidarity is appointed by the United Nations Human Rights Council to develop a draft declaration on the right of peoples and individuals to international solidarity.

The mandate on of the independent expert on human rights and international solidarity was created in 2005 by the predecessor of the Council - United Nations Commission on Human Rights (see resolution 2005/55). In 2011, the Council extended the mandate for a further period of three years (see resolution 17/6).

Stages of Implementation

Ms. Virginia Dandan, has set three stages in the implementation of her mandate: the elaboration of a draft declaration on the right to international solidarity.

The past work is to be understood as Stage One, where international solidarity had been affirmed in various ways, including as:

- a fundamental conception of mutually reinforcing relations among persons, groups and nations;
- an essential binding element that underpinned global partnerships,
- •a key approach to poverty eradication;
- an indispensable component of the efforts to realize all human rights, including the right to development, and the Millennium Development Goals.

During Stage Two, Ms. Virginia Dandan will set out to develop standards, norms and principles to guide the draft declaration.

Stage Three will be devoted to elaborating the draft declaration, and will culminate in its submission to the Human Rights Council by 2014.

Ms. Virginia B. Dandan is an internationally recognized expert in economic, social and cultural rights and served as the Chairperson of the UN

Committee on Economic, Social and Cultural Rights (CESCR) for eight years, from 1999 to 2007, having been a member of the Committee for twenty years. Ms. Dandan was appointed by the Human Rights Council as the independent expert on human rights and international solidarity in June 2011.



INTERNATIONAL SOLIDARITY

International solidarity is borne out of a need to build a more peaceful and just world where all can live a dignified life. International solidarity is a core-value and it is intrinsically part of all that is being discussed and done at the United Nations.



How to Get Your Annual UN Ground Pass

We explain the process for those NGOs who will be requesting their pass for the first time

First write a letter on the official letterhead of your organisation and send it to New York. Sample of this letter can be found <u>here</u>. Then write a second letter (sample <u>here</u>) for your Geneva pass and sent either by faxed or scanned and emailed.

The ECOSOC website has changed and it is important to have the details requested from Representatives. These are: Surname - Name - Middle Initial - Permanent Address - Telephone - Place of Birth - Date of Birth - Hair Colour - Eye Colour - Height - Weight - ALSO: First and Last Name and Telephone number of Emergency Contact.

For each duty station (NY, Geneva and Vienna) each NGO can appoint five Representatives (of which one is the Main Representative) and two additional Executive Officers. The NGO can decide to give their Main Representative accrediting rights.

Here are the steps:

- 1) Go to http://esango.un.org/paperless/Web?page=static&content=designation
- 2) Second window on right is Civil Society Database and click on NGO Login.
- 3) Log in with NGO username and password and you' will be directed to your NGO page.
- 4) Under Consultative Status scroll down to Designations. Start with NY, then proceed with Geneva and Vienna.
- 5) To confirm an already existing name for 2013 renewal:
- 6) Click on the person's name and at the bottom of the page you will find 'Update"
- 7) Click on "Update" and first update duty station: for it to be NY, Geneva and/or Vienna and the type of representative.
- 8) Click on person's name and update duty station of representation: for it to be NY, Geneva and/or Vienna and the type of representative.
- 9) Then update the dates from 01 January 2013 to 31 December 2013.
- 10) "Submit" and you should get an email confirmation within 48 hrs.
- 11) Do not forget to log out

AND...do not forget to scan or fax and send/fax/email the letter to the relevant NY and the UN 'duty' station (UN offices Geneva/Vienna)

It is advisable to contact the NGO Liaison Office in Geneva before going to the UN to make sure that the details have been sent to Security so that an annual badge can be prepared. It has happened on a number of occasions that main office in NY had processed everything but not Geneva. Contact details for the Geneva Ground Pass:
