Dear Mr. Dobson:

I represent Veritox, Inc. Its principals have come into possession of a June 13, 2007 letter you wrote to Libby Omer. In short, at best, the letter is inappropriate and inflammatory; in all likelihood however, it has created liability for you and your firm regarding basic principles of libel.

In particular, I am curious to know the basis for your statement that "Veritox is a notorious and controversial band of 'hired gun' experts". Of perhaps greater importance, is your bald-faced unsupported assertion that "... their conclusions and theories are generally unbelievable and fall outside mainstream scientific and medical thinking".

If you are truly familiar with Veritox, you are aware that they value their reputation above all else. They certainly do not tolerate unsupported bald-faced incorrect, inflammatory and slanderous assertions of the like found in your letter. Unrebutted statements of this nature will not be allowed to stand.

As such, I respectfully request that you immediately provide the objective criteria upon which you base these inflammatory statements. If you are not able to provide any evidence for your statements, I respectfully request that you immediately retract the statement and issue an apology to Veritox and their principals. If these steps are taken, my clients will merely view the slander as inadvertent, over zealous remarks by a brash advocate without any further ramifications or intent to harm.

If the retraction and apology are not forthcoming however, my clients will aggressively pursue all of their legal remedies to clear their name. These statements are unacceptable.


