Nunez Foods Sells 330,000-SF Refrigerated Warehouse Portfolio

Industrial Realty Group acquired three industrial properties located at 6960 and 6831 NW 36th Ave. and 7007 - 7025 NW 37th Ave. in Miami, FL from Nunez Group International LLC for \$8.75 million, or \$26 per square foot.

The three buildings total 336,581 square feet and include 61 dock height doors and rail service by Active Rail.

Lincoln Property Acquires 11 Building Portfolio from TA Associates

Lincoln Property Company purchased a portfolio in Medley, Florida consisting of 11 Industrial Buildings and totaling 846,651 square feet for \$59.85 million, or about \$71 per square foot. The project was built between 1979 and 1987 and is comprised of both frontload and cross-dock facilities with 20-foot to 24-foot clear heights and Florida East Coast (FEC) rail access.

The park was 95 percent occupied at the time of sale with strong credit tenants like B/E Aerospace, Eco Window Systems, and Konie Cups International. The sale represents the largest industrial trade in Miami to date this year.

ORLANDO, FL, Greg Morrison, SIOR, CCIM, Principal of Morrison Commercial Real Estate, announced the completion of the sale of the 4,931 square foot office building located at 200 South Central Avenue, Oviedo, FL 32765.

In one of the largest office leases in Miami so far this year, Royal Bank of Canada has renewed its lease and expanded by more than 10,000 square feet to occupy a total of 65,009 square feet at 801 Brickell Ave. in Miami, FL.

Amazon Rumored to Build 1 Million SF in South Shore Corp Park, Tampa

Could it be possible? In an article written by the Tampa Business Journal, talk of Amazon building a 1 million-square foot warehouse on 70 acres in South Shore has many people saying that Ruskin's time may have finally arrived.

"If Amazon comes it would be very positive," said Brian Smith, senior pre-construction manager for Ryan Cos. US Inc., which owns the land. Ryan is reported to have paid \$28 million for 302 acres in 2007.

Becker & Poliakoff Leases 46,000 SF in Fort Lauder-

The new lease, totaling more than 46,000 square feet, culminates a significant refurbishment and turnaround for the office building, which was purchased by Ivy Realty in 2011.

Becker & Poliakoff will be moving in January 2014 where they will be establishing their headquarters on the top three floors of 1 East Broward, a luxury, Class A office building in downtown Fort Lauderdale.



The site is the largest industrial site closest to Miami International Airport, PortMiami, downtown Miami and Miami Beach. It is currently occupied by a 485.000 square foot rail served distribution center built by Winn Dixie in 1960 for food distribution.

Along with releasing the existing building Keating said that based on strong demand the group is considering building a 400,000 square foot 40' clear Elias height port centric cross dock distribution center which would be the largest speculative building ever to be built in Dade County.
