### **Recent Trip Report**

During the last couple of trips, we have had products turned back at the border. In June we could not take the oats and July we could not take powdered milk. These products were turned back by officials from Mexico's agricultural department even though we had a letter for the items from DIF. When we face this situation, the products have to be returned to the warehouse. Fortunately, we were able to reach the truck that delivered to Tecate, CA, and they came to the inspection area and took the oats and milk back to the warehouse. The frustrating part is when this occurs at the border, we are not able to replace the products with what can be purchased in Mexico on that short of notice.

We have since found a source in Mexico for the oats and powdered milk for the August trip, but at a higher price. Unfortunately, our order was not ready when we arrived and this added a couple more hours to the day. The cost for the oats and milk are higher in Mexico with the milk being one of the more expensive products to deliver.

Please don't think the trip was all bad. We still made all the planned deliveries of the allowed products and continue to thank God for a safe trip and a day spent with fellow believers, and it is always a blessing visiting the ministries the Lord has called us to support.

Warehouse space in Bloomington, owned by **Dalton Trucking**, was made available to us for the same generous price of **FREE**. MCCA began working out of that warehouse in November of 2013. It was a modern facility, and it was a real blessing to load trucks there and store the products we take to Mexico on a monthly basis.

In the spring of 2014 we were notified that the property might be sold. The owners had received a generous offer they could not refuse. With that being said, we once again found ourselves looking for a new location.

One of our long time supporters offered us the use of a building in Calimesa. All we had to do was to clean it and

make some minor repairs.

#### MCCA at a Financial Crossroad

For the past fifty years, MCCA, and the ministries that we serve in Baja California, have received, and have been blessed, with your financial and spiritual support. **Thank you**, and may God continue to bless you for all that you do for MCCA. You, our faithful supporters, have helped us feed thousands each month

It hasn't helped that Mexican border authorities prohibited us from taking oats (in June) and powdered milk (in July) into Mexico. These restrictions are continuing until we are told otherwise.

We are looking for reasonable and reliable sources for these products in Mexico, but what we have found so far has been more expensive than what we had paid for the same products for many years in the U.S.

The rising food costs in both Mexico and the U.S. are making it more difficult for MCCA to maintain its level of support for our current recipients. The need is great, and most of those we already help do not receive any other regular donations of staple food items like those supplied by MCCA. There are many who need our help.

Some of you may not know that MCCA has no paid staff, just volunteers. Our drivers willingly pay for all their expenses to make the monthly trips delivering support into Baja California. Ninety-seven percent of all donations received by MCCA are spent directly on food, Bibles, and other items that are distributed to ministries in Mexico. The other three percent is spent on insurance, miscellaneous fees and costs. Other administrative costs are picked up by the members in order to maintain the three percent limit.

Please pray with us that more donors will join you in supporting MCCA. No amount is too small; our GOD can multiply all things for His honor and glory through MCCA and you.
