RE: Please rescind ACJ endorsement of San Diego Judge Lisa Schall for re-election

Dear ACJ Directors,

I have been a strong supporter of the ACJ. I understand the need to restore trial court say in the distribution of branch funds for the purpose of restoring autonomy in the courts.<sup>1</sup> It was with great sadness yesterday that I became aware of the ACJ endorsement of San Diego Judge Lisa (SCHALL) for re-election. Her campaign motto is, "Injustice anywhere is a threat to justice everywhere."<sup>2</sup> This is true and she has earned a well deserved, bad reputation for injustice in her courtroom being a threat to justice for thousands of U.S. citizens.

I can personally attest and provide the direct evidence that her acts in her courtroom have aided to keep the House That George Built on a solid Speak With One Voice foundation; adverse to the interest of the trial court judges and the public they serve. In 2005, I published a writing exposing how it became a scientific fraud in US public health policy that toxic-biocontaminants in water damaged buildings could never reach a level to harm. The acts of SCHALL have helped to cover-up that MCCONNELL fixed the 2006 anti-SLAPP opinion over my writing; with HUFFMAN and BENKE then covering up for MCCONNELL and SCHALL in the 2010 Appellate Opinion. As a result of collusive misconduct, material court document falsifications, concealment of the falsifications and continued usage in several San Diego courts; many lives across the U.S. continue to be greatly harmed to this very day as the scientific fraud I first exposed in 2005 plays on in many U.S. courts.<sup>3</sup>

In my SLAPP matter in her court, the judgment was not properly noticed and is fraudulent on its face. False hearsay documents, not discussed in trial, got into the jury room<sup>4</sup>. Being aware of these facts, SCHALL refused to even hear oral argument for a new trial. Her clerk falsified CCMS entries and back dated the judgment -- not once, but twice. A fraudulent abstract of judgment was recorded – contradictory to the face of the void judgment, and proving the judgment is void on its face.<sup>5</sup> These are not just unethical acts; they are criminal acts when colluding in Honest Services Fraud to fleece the United States public with the plaintiffs, their counsel, and George inner-circle justices. The plaintiffs are toxic tort expert defense witnesses for the U.S. Department of Justice and for many private sector insurers/employers.

The oral arguments occurred on December 12, 2008. I was SCHALL's last victim on her last day before she was moved to family court – where her reported unethical behavior and injustices to families, are reported to be equally outrageous, dishonest,


and devastating to families.<sup>6</sup> There is a federal racketeering suit filed by a families' and children's non-profit advocacy group with SCHALL being a primary named defendant; along with others who are now endorsing her for re-election.<sup>7</sup>

The co-defendants' names are listed right beside the ACJ's on SCHALL's re-election website.<sup>8</sup> Is this really what ACJ stand for or a wise image to project while seeing support of the legislature for greater say in judicial branch decisions? To the public, an ACJ endorsement of SCHALL gives the appearance that the ACJ is not motivated to restore integrity to the courts. They are only interested in gaining greater control of the judicial branch's money; while offering no change to the systemic ethics problems. This endorsement makes the ACJ appear to have no more integrity than those within the AOC/JC who the ACJ professes to be in existence to fight on behalf of restoring the branch to a "predicate for democracy".

The endorsement is adverse to the five-hundred CJA members' interest, statewide, when seeking a balance of power in the California judicial branch. It is disrespectful to the legislators who have stood up for the ACJ, against tall odds. It offers a valid argument to leave the judicial branch status quo, with the AOC and JC controlling the portrayed dysfunctional, trial court judges and their coffers. This in turn, harms the public.

I am not asking the ACJ to endorse the candidate<sup>9</sup> who is running against SCHALL. I merely ask that the ACJ rescind this endorsement. It is my hope that the Directors will take this matter to ACJ members to vote as to whether to continue with the endorsement of SCHALL. Thank you for your consideration of this request.
