Contributions or gifts to Lea Marquez Peterson for Congress are not tax deductible as charitable contributions and are subject to the prohibitions and limitations of the Federal Election Campaign Act. An individual may contribute a maximum of \$2,700 for the primary, \$2700 for the primary runoff and \$2700 for the general election. Federal multi-candida political action committees (PACs) may contribute up to \$5,000 per election. Contributions from corporations, labor organization treasury funds, foreign nationals, and federal government contractors are prohibited. All contributions must be from the contributor's personal funds. Corporations and individuals are strictly prohibited from reimbursing another person for making a contribution to Lea Marquez Peterson for Congress. To comply with federal law, we must use our best efforts to obtain and report the name, mailing address, occupation and employer of all individuals whose contributions aggregate in excess of \$200 per election cycle.
