Dear Editor:

I am writing to voice my support for Ohio's proposal to link eight initial stations between Cleveland, Columbus, Dayton and Cincinnati with modern, 79 mph passenger trains. This infrastructure project will immediately create 255 construction jobs and result in thousands more indirect and spin-off jobs, as has happened in less populous states like Maine, Michigan, Oregon and Wisconsin.

The 3C rail project will raise property values around stations, promote redevelopment in our town centers, modernize the freight rail system and reduce shipping and travel costs for Ohio's employers.

There are more than 200 rail industry supplier companies here, employing over 25,000 Ohioans. They have built rail systems for other states and nations. Now they can build one in their own backyard to link Ohioans regardless of their age, income or physical ability with new economic opportunities.

Ohio was fortunate to win \$400 million in federal rail funds for the 3C project. Let's use this to expand Ohio's economy, add jobs and provide low-cost transportation between the

Dear Editor:

I support Ohio's proposal to link eight initial stations between Cleveland, Columbus, Dayton and Cincinnati with modern, 79 mph passenger trains. Ohio won \$400 million in federal rail funds to build a foundation for higher-speed trains and enhanced freight rail infrastructure in America's ninth-most densely populated state.

Ohio's 3C trains will be the most comfortable, productive, least expensive way to travel and be America's fastest trains for a new-start rail service in 20 years. AECOM, one of the most respected transportation planning firms, predicts 3C will be the nation's 12th busiest rail service.

Stimulus funding for trains and transit creates twice as many jobs as the same funding for roads, the U.S. Public Interest Research Group says. Yet some complain that public funding will go to rail. What a double-standard. Our rail system is mostly privately funded while our highway system is the real ward of the state. Annual funding for 3C trains will be just 0.005 of ODOT's budget. The rest is for highways.

The 3C trains will mean thousands of jobs and \$1.2 billion in benefits for Ohioans. Would Ohio have refused federal highway construction money because it meant having to hire more state troopers or operate more snow plows?

Dear Editor:

I am writing to voice my support for Ohio's proposal to link eight initial stations between Cleveland, Columbus, Dayton and Cincinnati with modern, 79 mph passenger trains. Ohio's 3C trains will be the most comfortable, least expensive way to travel and offer the fastest trains for a new-start rail service in the U.S. in 20 years, All Aboard Ohio says.

I want to use 3C trains because <u>(keep to 20 words)</u>. Based on Midwest rail fares, 3C will be one-fifth the cost of driving and less than a cramped, slow bus.
