- WHO is a way to recognize length and depth of service (i.e. participation on Rep Council, Executive Board, standing and/or ad hoc committees.)
- Each person honored at the luncheon will be awarded a certificate, a trophy and a lapel pin.

Guidelines for Nomination

- Only FUDTA Unit Members may nominate fellow members for the WHO Award.
- Unit Members must be nominated by someone other than themselves.
- Any nominations received that have derogatory comments about other unit members will not be considered.
- You can nominate people who have already received the WHO that still continue to serve FUDTA.
