**WHAT THIS CASE IS ABOUT; WHY THIS COURT HAS ORDERED I COMMIT PERJURY ON THE INTERNET – OR GO TO JAIL FOR REFUSING TO LIE; and WHAT IS AT STAKE FOR THE AMERICAN PUBLIC**

In 2005 I, Sharon Kramer, exposed how a science fraud was mass marketed into US public health policy that two guys with PhDs had proven moldy buildings do not harm by applying math to data taken from one rodent study. They did it to stave off liability for stakeholders of moldy buildings. The courts, particularly a couple of justices from the inter-sanctum of the helm of the CA judicial branch, helped the two guys frame me for libel for the writing which aided the fraud to continue to devastate the lives of tens of thousands environmentally injured and dying.

Seven years later, the court has now ordered me to post a false confession on the American Industrial Hygiene Association "AIHA" Linked In board that I am guilty of defamation for a sentence I never even wrote. This is to help conceal they framed me for an entirely different sentence in my March 2005 expose'; and by doing so have been defrauding the public out of billions of dollars by criminal means that are bold faced hate crimes against those disabled by the moldy buildings; and to conceal that they already locked me up once, March 2012, for refusing to be coerced to sign a false confession.

The court has issued a decree that I must now post the court known false confession on the internet - or go to jail for alleged civil contempt of a proven uncivil court. Wild horses (and wily judges) could not make me publish fraud on the internet to help conceal the corrupt California courts have aided and abetted false science in environmental health policy while lives continue to be devastated daily. On Aug 30, 2012, the Court issued the above Tentative Ruling denying my "MOTION TO VACATE VOID CORAM NON JUDICE 'JUDGEMENT AND ORDER FOR CIVIL CONTEMPT AND PERMANENT INJUNCTION' in Criminal Violation of C.C.P.1209(b)"; with no explanation given. It is highly unlikely at best that he will change his mind by oral argument tomorrow. They just keep digging a deeper hole, obviously thinking no one will ever stop them. Let's hope they are not right.
