

JULIAN ASSANGE TIMELINE: 8/1/18 – present

Something is in the works with Julian Assange. It's been building since summer and tensions are now reaching a peak. Sometime will happen soon, and it may have major implications for the midterms, FISA, and the exposure of other DS operations. Below is a summary of recent news involving Assange starting at the beginning of August.

I am an experienced researcher in several fields but a latecomer to Q research, and therefore request the help of more experienced anons with answering the questions below. (Also, let me know if any corrections are needed.)

Part I provides background for newbies; **Part II** shows the timeline since 8/1; **Part III** lists remaining questions that require further research.

PART I: BACKGROUND

How did Assange end up in the Ecuador Embassy? And why do whistleblowers like Snowden and Assange choose Ecuador as a destination? Because although it has a bilateral extradition treaty with the US, the 1948 Universal Declaration of Human Rights and the Geneva Convention takes priority. The Ecuadorian government cited both after they granted Assange diplomatic asylum on the grounds he "would not have a fair trial" if extradited to the US.



Assange has been marooned in the Ecuadorean Embassy for extraordinary period of time, from June 2012 until now (late 2018). While he obviously has many enemies, it's still not clear what has been happening with Assange and Wikileaks from the end of 2017 until the present. In March 2018, he was largely cut off from the outside world, including the Internet. So in effect, since March, Assange has gone dark. But recently, there has been more activity around Assange, starting with the US Select Senate Committee on Intelligence (SSCI) wanting Assange to testify behind closed doors in Aug.; although Rand Paul tried to arrange for a deal where he would be given immunity, this didn't happen. So Assange's lawyers are apparently "still considering" the request as of late October.

On Aug. 11, the DNC served Wikileaks with a subpoena via Twitter, in their suit against the Trump White House where they claimed that Wikileaks colluded with the Trump campaign to rig the 2016 US election.

Around the middle of Sep to Oct (dates vary), several unvetted articles appeared announcing that Julian Assange had damning information on HRC that he would release on Oct 21 unless she were indicted by then; this is similar to a claim made two years ago in 2016. (These articles appear to be bogus, but why do they exist at all??)

Starting in late Sept, activity around Assange significantly steps up:

On **Sept 24**, articles appear about a previously aborted plan to smuggle Assange from the Embassy to Russia. Two days later, Wikileaks names a new editor, Kristinn Hrafnsson, to replace Assange. On **Oct. 14**, we hear that Assange will be given the ability to communicate with the outside world although with limitations, although we don't hear this directly from Assange. On **Oct. 19**, it is said that Assange is suing the Embassy for the treatment he has received. As of **Oct. 28**, he has not worked out his problems with the Embassy and it is unclear what the immediate future holds.

According to RT, Ecuador will "no longer intervene on behalf of Justin Assange in talks with the UK over his exile status." PART III: QUESTIONS

Q Posts: There are two recent posts that pointedly discuss Assange. The last half of Post 1842 tells us that the SSCI want Assange to testify; Post 1968 shows us an anon inquiring, "What's happening with Assange?" Q replies that our enemies are also monitoring this board and tells him to "see above." **Why not ignore the question? What is Q trying to tell us?**

Other Questions:

1. **Who decided the "name" a new editor to Wikileaks?** Could it possibly have been Assange? Somebody else? Did the guy appoint himself? Is he aligned with Assange or with Snowden?
2. **Could some of these current stories on Assange be distractions to cover up what's really happening** (like the fact that he may no longer be at the Embassy--or that he actually comes and goes?)
3. **Why were Rand Paul's calls for immunity for Assange last summer ignored by the SSCI?** (Did he make a public plea to show up the committee's insincerity? What do they want? Are they the driving force behind the current effort to extradite Assange?)
4. **What is the current relationship between Wikileaks & Freedom of the Press Foundation?** In Dec 2017, FPF was slated to cut ties with Wikileaks: <https://www.washingtontimes.com/news/2017/dec/20/wikileaks-set-lose-support-freedom-press-found/> This appears to have happened. Who was in control of FPF's Board at that time? Who is in control now? <https://cafe-babylon.net/2017/12/21/julian-assange-responds-to-the-freedom-of-the-press-foundation-cutting-wl-loose/>
5. **In Jan-Feb 2018, the people who were most closely associated with SecureDrop (formerly DeadDrop) die unexpectedly:** James Dolan (suicide), Aaron Swartz (suicide), and John Perry Barlow ("heart problems"). Kevin Poulsen turns over Securedrop to Freedom of the Press and goes on to work as Senior National Security reporter for The Daily Beast, focusing heavily on Russian election hacking (https://www.msnbc.com/rachel-maddow/watch/mccaskill-id-d-as-first-2018-target-of-russian-hackers-report-1286527555949?v=railb&playlist=associated&cid=sm_npd_ms_tw_ma; this is a Rachel Maddow report; see Poulsen @ ~7:00).
6. **Who currently controls the FPF?** Is it the head of PayPal, Pierre Omidyar? <https://www.mintpressnews.com/displacing-wikileaks-is-securedrop-a-government-leak-graveyard/238339/>

7. **Who controls Paypal?** Is it mainly Omidyar? Soros? Soros has owned shares in Paypal since 2015 (<https://www.businessinsider.com/george-soros-has-made-a-big-bet-on-paypal-2015-11/>) and also uses his lobbying group to remove Paypal access to groups he doesn't like, like InfoWars (<https://www.thegatewaypundit.com/2018/09/paypal-is-latest-tech-giant-to-ban-infowars-after-soros-group-lobbying/>). And more recently, Soros may be behind the Paypal ban on Gab (<https://www.zerohedge.com/news/2018-10-27/paypal-bans-social-network-gabcom-after-synagogue-attacker-revealed-user>).
8. **What's the current situation with SecureDrop** (still a data collection tool of C_A)? It now appears to be used by a long list of MSM news organizations (Wikipedia).
9. **When I search on SecureDrop on the Internet, it is still touted as a safe drop for whistleblowers.** I wonder how safe it would seem if the public had read Q Posts 628 or 770. (628 tells us that everything dropped into SecureDrop--which is now used by all the MSM--goes straight to the CIA. 770 expands the picture, mentioning that all the original developers or others who "knew too much" are now dead, since Feb 2018, and asks questions about the current controllers of FPF--the Snowden group including Greenwald, Ellsberg and Poitras. Asking "Who controls Snowden?", Q implies more than once that Snowden is now a marked man.
