

Marriage of Freitas 12/3/12 209 Cal.App.4th 1059 reversed error

Mark T. v. Jamie Z. 4/28/11 194 Cal.App.4th 1115 reversed and remanded. schall misunderstood the pertinent law, abused her discretion by failing to apply the proper legal standard, and her order was based on the application of improper criteria or incorrect legal assumptions.

F.T. v. L.J. (3/8/11) 194 Cal.App.4th 1 reversed and remanded with directions. schall "apparently misunderstood the proper legal standards to apply" in determining child move away, abused her discretion, was "influenced by an erroneous understanding of the applicable law or reflects an unawareness of the full scope of [her] discretion"

Marriage of Fernandez-Abin and Sanchez (1/11/11) order reversed with instructions. schall did not base her decision on the appropriate statute, did not follow the requirements of the statute, and disregarded the exclusive continuing jurisdiction of a foreign court over the child custody matter she proceeded to adjudicate.
