Dear Senator Feinstein,

I write today to request your assistance in curtailing an unholy union between the State of California and the United States governments along with private sector contractors, which is harming thousands with false science, including military families residing in poorly constructed and poorly maintained military housing.

I have provided extensive evidence to you which proves that the State of California is involved with federal contractors of the United States Department of Justice (USDOJ) in the promotion and ongoing usage of false science, used to avoid liability for brain injuries of the families who live in water damaged military housing.

The misuse of science is being perpetuated by use of four articles published by influential U.S. nonprofit associations which contradict more than a thousand published scientific papers.

These articles are used by USDOJ toxicologist contractors, Department of Defense (DOD) housing contractors, their insurers, and their insurers' attorneys who continue to say that moldy water damaged housing is not the source of newly-acquired cognitive-dysfunction reported by the military families and thousands of others across the United States.

If these articles were to be retracted then no one could use them to justify inactivity for cleaning up water damaged housing, including but not limited to, military housing. Three of the four articles carry the esteemed name of the University of California which lends strength to the flawed science they contain, and the fourth is based on the other three.

Please intercede to encourage the Governor and the Regents of the University of California to demand that the following three papers carrying the esteemed University of California name be retracted from publication:

1. *“Adverse Human Health Effects Associated with Molds in the Indoor Environment”* by Bruce J. Kelman & Bryan D. Hardin of Veritox, Inc. and Andrew Saxon of the University of California Los Angeles (UCLA)
Published in the Journal of Occupational and Environmental Medicine (JOEM)
2. *“A Scientific View of the Health Effects of Mold”* Stated authorship of Bruce J. Kelman, Bryan D. Hardin, Coreen Robbins of Veritox, Inc. and Andrew Saxon of UCLA.
Published on the website of the U.S. Chamber of Commerce
3. *“The Medical Effects of Mold Exposure”* Stated authorship of Andrew Saxon of UCLA, Robert Bush of University of Wisconsin, Abba I. Terr of Stanford University, Robert Wood of Johns Hopkins Hospital, and Jay Portnoy of Children's Mercy Hospital of Kansas City.
Published in the Journal of Allergy and Clinical Immunology (JACI)

I have been revealing the truth about the hazards caused by the false concepts promoted by the above three papers since 2005. I have been subjected to fourteen years of strategic law suits brought by the USDOJ's toxicologist contractors, Veritox, Inc., who rely upon them to lend undo credibility to their "expert" opinions.

I continue to experience judicial retaliation in California for being a whistleblower of false science used by federal contractors to harm military families and others, nationwide.

I am asking you to intercede with the Attorney Generals of California and of the United States to bring me relief from the harassment which has terrorized me since 2005. The ongoing harassment is for the purpose of obstructing justice for thousands by obstructing justice for one.

The harassment's intent is to aid avoidance of government and insurer liability for negligent acts which cause brain injuries to military families and thousands of others across the United States, who reside and work in moldy housing and workplaces.

Please initiate an impartial investigation of the judges and justices in San Diego, California and their unlawful protection of the USDOJ's toxicologist contractors, Veritox, Inc. The actions of the courts in cooperation with Veritox and their attorneys have caused me to be unjustly framed for libel, to be subjected to large financial liens, and to be physically harmed.

They have led to an unsettling threat made by a judicial court officer in October 2018 of more harm for my continuing to tell the truth, in the public's best interest, of false toxicological science and problems in the San Diego courts which enable it.

On behalf of my family, military families, and all other U.S. families and workers who are continuing to be harmed by water damaged buildings and misinformation regarding the health effects of the toxins of mold; I thank you for your prompt attention to this matter.
